The Fiscal Year 2020 Fourth Quarter Report is for the reporting period from July 1, 2020 through September 30, 2020. Information contained in this report pertain to the purpose and powers of the Budget and Finance Committee ("Committee") of the Navajo Nation Council, included are the resolutions enacted and significant activities and accomplishments of the "Committee" during the reporting period.

PURPOSE OF THE BUDGET & FINANCE COMMITTEE

Pursuant to 2 N.N.C. §§ 300 et seq, the purpose of the Budget and Finance Committee is:

- A. Budget and Finance Committee is hereby established as a standing committee of the Navajo Nation Council.
- B. The Committee shall consist of six members.
- C. The Committee shall exercise oversight authority including but not limited to budget, finance, investment, bonds, contracting, audits, accounting, taxes, loans, Chapter budget and finance for the following purposes:
 - 1. To Coordinate, oversee and regulate the fiscal, financial, investment and audit polices of the Navajo Nation;
 - 2. To report to the Navajo Nation Council on the fiscal and financial state of the Navajo Nation;
 - 3. To recommend to the Navajo Nation Council the adoption of legislation designed to strengthen the fiscal and financial position of the Navajo Nation to promote the efficient use of the Fiscal and financial resources of the Navajo Nation;
 - 4. To protect the interests of the Navajo people through the prudent management of the financial reserves of the Navajo Nation and the use of funds available for expenditure by the Navajo Nation;
 - 5. To act as an Audit Committee of the Navajo Nation government.

Committee Meeting Schedule

All regular meetings for the Budget and Finance Committee are held on the first and third Tuesday of each month, pursuant to 2 N.N.C. § 302.

INTRODUCTION

This report identifies areas of Committee oversight activities during the Fourth Quarter of Fiscal Year 2020, which includes the months of July, August and September 2020. During the reporting period, the Budget and Finance Committee approved a number of reports in the area of budget related issues; the Committee considered and recommended approval of 27 legislations this quarter.

In <u>July</u>, the Committee held 1 regular meeting, 2 special meetings 5 work sessions/leadership; and in <u>August</u>, the Committee held 1 regular meeting 1 special meeting, 3 leadership/updates/work session and 3 oversight budget hearings; In <u>September</u> the Committee held 2 regular meetings, 2 special meetings, 1 work session and 10 comprehensive budget hearings for a combined total: 4 regular meetings, 5 special meetings, 9 work sessions/leadership/updates, and 13 budget hearings for a combined total of 31 meetings during the 4th Quarter of FY2020. The Committee convened 31 meetings this quarter.

SUMMARY OF SIGNIFICANT ACTIVITIES AND ACCOMPLISHMENTS

The following is a summation of key issues brought before the Budget and Finance Committee of the Navajo Nation Council during this reporting period. If additional information is needed, the Budget and Finance Committee journals are available for public review upon request from the Office of Legislative Services, Budget and Finance Committee Legislative staff.

A brief summary of the Issues presented at Committee Meetings during the Fourth Quarter:

CORONAVIRUS AID, RELIEF, and ECONOMIC SECURITY ACT (CARES ACT) FUNDING and COVID 19

The Navajo Nation received an aggregate total amount of \$750,900,283.52 allocated from the US government to provide relief to the Navajo Nation from the CARES Act/COVID 19 as of August 18, 2020. Included in the total amount is \$17,497,908.07 federal funds awarded to several Navajo Nation programs/departments to provide relief for Covid 19 related expenses, with \$912,452.74 expended and \$735,732.72 open commitments for a remaining balance of \$15,849,723.01.

The CARES Act funds are intended to provide relief to tribes from March 1, 2020 thru December 30, 2020 for COVID related expenses. Concerns have been expressed by tribes that they received CARES Act funding 51 days after enactment of the Congressional legislation and they are requesting an extension for expending the funds.

FY2021 BUDGET PROCESS

The Committee considered 10 budget legislations including oversight budgets and the Navajo Nation Comprehensive during this quarter. The 3 Branch Chiefs recommended the General Fund budget amount of \$167, 142,353 for FY21. \$1,244,353,093 is the overall budget for the Navajo Nation for FY21. The budget legislation No. 0224-20 was tabled on September 25, 2020 for up to 45 days and a Continuing Resolution CS-77-20 was approved by a vote of 19-1. Continuing Resolution funds the Navajo Nation government at ¼ of the total budget for 1 quarter of the fiscal year from October 1 thru December 31, 2020, which is approximately \$42,537,052.

CAP-35-18 SIHASIN CHAPTER PROJECTS

The Committee reviewed 3 legislations, with 1 considered an administrative matter, considering changes in project funding from year to year, changes in scope of the projects and changes to project type for several chapters this quarter. The Committee is final authority on the requested changes to funding chapter projects appropriated pursuant to Council Resolution CAP-35-18.
