BE IT ENACTED:

SECTION ONE. AUTHORITY

- A. The Resources and Development Committee is a standing committee of the Navajo Nation Council with the delegated responsibility to "establish policies and legislation appropriate to the housing needs of the Navajo Nation and its People." 2 N.N.C. §500, §501(C)(3).
- B. The Health, Education and Human Services Committee is a standing committee of the Navajo Nation Council and exercises oversight authority over veterans' services, among other duties and responsibilities. 2 N.N.C. §400, §401(C)(6).
- C. The Budget and Finance Committee is a standing committee of the Navajo Nation Council that has the authority to review and recommend the budgeting, appropriation, investment, and management of all funds. 2 N.N.C. §301(B)(2).

1 D. The Law and Order Committee is a standing committee of the Navajo Nation Council with
2 the delegated responsibility to “review and make recommendations to the Navajo Nation
3 Council on proposed amendments to and enactments to the Navajo Nation Code.” 2 N.N.C.
4 §600(A), §601(B)(14).

5 E. The Naabik’íyátí Committee is a standing committee of the Navajo Nation Council with the
6 delegated responsibility to recommend resolutions to the Navajo Nation Council. 2 N.N.C.
7 §700, §701(A)(3).

8 F. The Navajo Nation Council is the governing body of the Navajo Nation, and as such is
9 empowered to amend Navajo Nation law. 2 N.N.C. §102.

11 **SECTION TWO. FINDINGS**

12 A. The Navajo Nation Veterans Trust Fund, 12 N.N.C. §§1171 - 1176, was established to
13 provide funding for programs, projects and services or activities for Navajo veterans.

14 B. During the FY2022 Comprehensive Budget process, confusion arose regarding allocation of
15 funds for local chapter veterans’ organizations. Some funds were allocated in a single
16 business unit for various local chapter veterans’ organizations. This use of a single business
17 unit number has concerned local chapter veterans’ organizations because with this procedure
18 there is no way to determine the amount of funds allocated for each of their respective
19 organizations.

20 C. Clarity and transparency is recommended by Navajo veterans and they have therefore
21 requested that the Navajo Nation Veterans Administration create individual business unit
22 codes during the comprehensive budget process for each of the several local chapter
23 veterans’ organizations.

24 D. The Navajo Nation Council recognizes that there is a need to continue and prioritize funding
25 for Navajo veterans, particularly at the local level.

27 **SECTION THREE. APPROVING AMENDMENTS TO 12 N.N.C. § 1176**

28 The Navajo Nation hereby amends the Navajo Nation Veterans Trust Fund, 12 N.N.C. §1176,
29 as follows:

Title 12. Fiscal Matters

Subchapter 8. Navajo Nation Veterans Trust Fund

§1176. Expenditure of Trust Fund

A. 75 percent (75%) of the total income earned, plus the current projected set aside of the Fund ~~will~~ shall be used as supplemental funding for programs and services to benefit veterans, as noted under §1172 on an annual basis, excluding two percent (2%), which shall be for the exclusive use of the Veterans Housing Program in accordance with 2 N.N.C. §1171(A) and with Navajo Nation Council Resolution No. CS-56-17. The Fund's income earned at the end of the previous audited fiscal year, plus the current fiscal year projected set aside, will be used to determine the allowable expenditure (i.e., budget purposes). The excess of the Fund income over expenditures shall be reinvested in the Fund to cover the rate of inflation and to provide for reasonable Fund growth.

B. Tribal grants to non-tribal government programs and projects shall be awarded in accordance with rules and regulations developed by the ~~Department of Navajo Nation Veterans Affairs Administration~~, in consultation with and approved by the Health, Education and Human Services Committee of the Navajo Nation Council and, if required, the Navajo Nation Council.

C. Of the 75 percent (75%) of the Fund, ~~total amount as set forth as described in paragraph A,~~ ninety-five percent (95%) ~~of the proceeds will~~ shall be used for the purposes set forth in Subsections (A) and (B) of this Section and five percent (5%) ~~will~~ shall be used for administrative purposes, ~~and this will be reviewed further by the Office of Management and Budget and the Program.~~

D. The Navajo Nation Veterans Administration shall maintain a separate business unit for budgeting purposes for each local chapter veterans' organization whose plan of operation has been duly approved by its respective certified/non-certified Chapter or Township.

Except as provided at §1171, all Trust Fund income distribution shall be determined pursuant to all eligible Navajo veterans and distributed among those applicable Navajo Nation chapters to be expended in accordance with §1172 of this Plan.

4 **SECTION FOUR. EFFECTIVE DATE**

5 This legislation shall become effective in accordance with 2 N.N.C. §221(B).

7 **SECTION FIVE. CODIFICATON**

8 The provisions of this legislation that amend the Navajo Nation Code shall be codified by the
9 Office of Legislative Counsel. The Office of Legislative Counsel shall incorporate such
10 amended provisions in the next codification of the Navajo Nation Code.

12 **SECTION SIX. SAVING CLAUSE**

13 If any provision of this legislation is determined invalid by the Navajo Nation Supreme
14 Court, or a District Court of the Navajo Nation without appeal to the Navajo Nation
15 Supreme Court, those portions of this legislation not determined invalid shall remain valid
16 and effective.





As Commander of the Eastern Navajo Veterans Organization, I am in total support of this legislation. It is imperative that each Chapter Veterans Organization receives their own Business Unit Number along with their own separate allocation of the Veterans Trust Funds.

The beginning of the current FY has been a total disaster. The entire ENA Veterans Trust Fund was depleted within two months. Many Veterans did not receive assistance, this was due to the manner in which the assistance requests were processed, with no accountability.


Many Veterans who did not need a specific type of assistance made the request and were awarded the funds, leaving many still in dire need. Agency Veterans Organizations and CVO's CANNOT wholeheartedly provide assistance to Veterans within their Chapters under the Consolidated Agency Budget Formula.

At an ENA Veterans Meeting, held 6 January 2022, many concerns were raised by Commanders of the ENA Veterans Organization. Commanders expressed the need for separate business accounts to better manage Trust Funds within their perspective Chapters. The Eastern Navajo Agency Veterans Organization is in total support of Separate Business Unit Numbers as indicated within Legislation 0024-22 and to return to the 50/50 Formula to allocate funding to Chapter Veterans Organizations.

Legislation 24-22

1. Sponsor does not have absolute consensus from the entire Navajo Veterans organization, many CVO's are in acceptance of one business unit at each agency to manage the trust fund budgets.
2. The reason for that is equal opportunity to receive trust fund assistance without waiting for a CVO meeting, waiting for a budget transfer (which takes about 2 or so months) or meeting a stringent rule that a CVO demands like having the veteran's residency for a period of six month to possible a year.
3. Trust fund is for every eligible Veteran, not just those who are favored to receive assistance by CVO officers or for other purposes but for equal financial assistance.
4. Previous years, B&F committee questioned trust fund carryovers, and have wanted to know why there was even any carryover. The one business unit utilizes all of the funds and so far, there is no carryover, which is something B&F committee wanted, for the funds to be expended not carried over.
5. Has the sponsor asked the about the time and effort that is required to manage 110 business units? These are administrative business and should not be demanded by someone who does not understand the process of administering a program.
6. My CVO, Nahodishgish is accepting of the one business unit administration of the trust funds, this allows use to help as many Veterans when they need it and for the sponsor to unilaterally make a demand without asking us is wrong and we request that the council vote no on this legislation or any other legislation that involves Veterans for these sponsors do not have the authority to seek changes.
7. Council needs to let the Navajo Nation Programs, administrations and departments do their jobs instead of impeding progress.

Hello everyone, my name is Eugene Marshall. I am the Veterans Commander for the community of Iyanbito, NM. It is in our best interest that we re-establish the Veterans Trust Fund Budget back to the local Veterans Chapter Organizations. By doing so, we (Veterans Organizations) will be able to have complete control of our budgets and we will have accountability of the funding. We will know who is getting what assistance and that will help us to be able to help more of our veterans.

The consolidated budget has its pros and cons. Yes, it is a quicker way to dis-burst funding, but it allows for any veteran to submit for funding with no limitations. This is why the Veterans Trust Funds budget was depleted in a two-month span and not all veterans were assisted.

I understand that the allocated dollar amount to each Veterans Organization will differ, and it will be based on the current veterans count for that chapter. With that being said, I would like to recommend that we (Veterans Affairs offices and Veterans Organizations) start requesting more funding from Washington. I recommend at least increasing it to 10%. So, 5% going to the Navajo Nation Veterans, 3% going to the Veterans Housing, and 2% going to the veterans administration. The veterans population is growing each year and we need to be able to assist all veterans in any way we can. This also gives the funding to allow for more veterans administration to help in all our veterans offices.

While funding was depleted in a short time span, it is time to request for a more funding for Navajo Veterans. At least a 10% increase as inflation is at its highest since the Raegan administration. 

WHEREAS:


1. The Eastern Navajo Agency Veterans Organization, as a sub-division of the Navajo Nation Government to serve in the best interest of Navajo Veterans, Spouses of Deceased Veterans, and Gold Star Mothers and,
2. The Eastern Navajo Agency Veterans Organization is comprised of 31 Chapter Veterans Organizations and,
3. The Eastern Navajo Agency Veterans Organization during a monthly teleconference meeting held February 3, 2022, discussed, and supports Legislation Number 0024-22, sponsored by Navajo Nation Council Delegate Kee Allen Begay, amending the Navajo Nation Veterans Trust Fund at 12 N.N.C. §1176 to create separate business unit numbers when funding the Navajo Chapter Veterans Organizations and,

APPROVING A REQUEST TO THE NAVAJO NATION VETERANS ADMINISTRATION TO RESPECTFULLY CLARIFY THE STATUS OF THE FY-2020 AND FY-2021 VETERANS TRUST FUND CARRY-OVERS BY STATING THE TOTAL AMOUNTS FOR EACH FISCAL YEAR. IF THE FUNDS WERE SPENT, INDICATE WHAT IT WAS USED FOR, WHO APPROVED THE EXPENDITURE? WE HAVE AN UNDERSTANDING THAT THE VETERANS TRUST FUNDS WERE SPECIFICALLY ALLOCATED TO MEET THE NEEDS OF THE VETERANS, SURVIVING SPOUSES, AND GOLD STAR MOTHERS.

WHEREAS:

1. Pursuant to Resolution CJ-S-40 of the Navajo Tribal Council, the Navajo Warriors (Veterans) were authorized to rearm to assist in defending the Constitution of the United States of America and the Democratic form of Government; ever since the 1940s, the Navajo Warriors (Veterans) has been unrecognized and treated as a "Special Interest Group" by their government; most endured many hardships and some that passed on never realized their earned Veterans' benefits and healthcare services; and
2. Pursuant to the Navajo Nation Council Resolution CMA-25-71, the Fort Defiance Agency Veteran Organization was established, and which also established the Department of Navajo Veteran Affairs within the Executive Branch of the Navajo Nation; and
3. Acknowledging that the Naschitti Community Governance Veterans Organization is entrusted to strive toward unification of the community veterans and other local resources to provide leadership and coordinate efforts to meet the needs of our veterans, surviving spouses, and gold star mothers; and
4. To our knowledge the Fort Defiance Agency Chapter Veterans Organization never received a carry-over for Fiscal Year 2020 and Fiscal Year 2021; and
5. We have been told that the Fiscal Year 2022 Veterans Trust Fund has been depleted as of January 2022; and
6. What happened to the carry-overs for the previous Fiscal Years; those carry-overs should have been used to replenish the depleted funds with; and
7. If there were carry-overs for the previous fiscal years, what happened to those funds? Were they put back into the Unreserved, Undesignated Fund Balance? If so, what were the amounts and why were we never told about that?; and

2. Pursuant to the Health, Education and Human Services Committee Resolution HEHSCJY-04-16; Navajo Nation Veterans Advisory Council Plan of Operation; Section I, II, III, IV, V, VI; The Navajo Nation Veterans Advisory Council is duly recognized by the Navajo Nation.
3. The Navajo Nation Veterans Advisory Council recognizes, understands and acknowledges NNVA Office Staff Shall Provide financial update, assistance, technical support and clarification, and shall maintain each fund account and provide monthly financial reports to each CVO.
4. The Navajo Nation Veterans Advisory Council recognizes, understands and acknowledges that the Veteran Service Officer, Accounts Maintenance Specialist and the Agency Veterans offices provide guidance and technical assistance on the Navajo Veterans Trust Fund Budgets allocated to the Chapter Veterans Organizations; and
5. The Navajo Nation Veterans Advisory Council understands and acknowledges the "one pot" funding systems did NOT and does NOT work as initiated by the Navajo Nation Veterans Administration Director; and
6. The Navajo Nation Veterans Advisory Council OPPOSE any amendments with out the consultation of the Navajo Nation Veterans Advisory Council; and

NOW THEREFORE BE IT RESOLVED THAT:

1. The Navajo Nation Veterans Advisory Council Supporting Legislation 0024-22; An Action Relating to The Resources and Development, Health Education and Human Services, Budget and Finance, Law and Order, And Council; Amending the Navajo

Nation Veterans Trust Fund At 12 N.N.C. § 1176 To Create Separate Business Unit Numbers When Funding Navajo Veterans' Organizations.

2. To amend the Veterans Trust Fund statute to require the creation of separate business unit numbers whenever Navajo Nation funds are awarded to local veterans' organizations.
3. The Navajo Nation Veterans' Advisory Council was educated, informed, and provided afforded time to discuss and debate and implement resolutions of support and or opposition.
4. The Navajo Nation Veterans' Advisory Council majority vote on this legislation shall speak to the legislation.
