Purpose of the Work Session: The Resources and Development Committee has scheduled a leadership meeting with the Department of Agriculture, Eastern Navajo Agency Council, Eastern Navajo Land Board, and U.S. Department of the Interior Bureau of Indian Affairs Eastern Navajo Agency to discuss on the recommended 2025 Grazing Rental Rate for Eastern Navajo Agency Lands.
